Adult Services

RESIDENTIAL

We offer comprehensive services for adults in residential settings. From the time the decision is made to admit a person until he or she is discharged the person remains the center of our efforts. Our well-trained and highly-experienced staff respect the important relationship with their patient. We treat each of our patient's loved ones with respect and courtesy.

Crisis Stabilization Emergency screening and referral for people in mental health crisis and/or withdrawing from drugs or alcohol; provides a secure and therapeutic inpatient environment for voluntary and involuntary mental health services and medically-managed treatment for people in withdrawal.

Residential Voluntary and involuntary addiction treatment including units for men, women, pregnant, and post-partum women, and inmates of the Florida Department of Corrections.

Women Assisting Recovering Mothers (WARM) A unique program for pregnant and parenting women and their infant.

Supportive Housing is available for people requiring long-term sober housing to support recovery; and transitional housing for adults with a severe or persistent mental illness.

OUTPATIENT

Outpatient Treatment allows the patient to interact in a real world environment while receiving a structured therapeutic program. Staff works with each individual to help them use the tools they have and learn how to sustain success in their lives. A variety of programs are offered with flexibility built in are conveniently located throughout our area.

Physician case management are for people with severe and persistent mental illnesses. A vocational rehabilitation program with psycho-social rehabilitation activities in a group setting is available.



FACT Team serves those at most risk of recurring hospitalization due to their chronic mental illness.

The Vince Carter Sanctuary Provides detoxification and residential addictions treatment for adults and adolescents, and outpatient mental health services for adults.

Addiction **Research** is conducted at The Sanctuary in conjunction with Shands Hospital's McKnight Brain Institute at the University of Florida.

Specialty Services

Pharmacy and Patient Assistance Program allows clients to obtain needed medications at the lowest possible costs.

Crisis Intervention Training for first responders to mental health emergencies including law enforcement, emergency medical technicians, correctional officers, and others with the goal of promoting safety, understanding, and service to persons with mental illness and their families.

Adolescent Services

Careful listening and clear communication are important when working with adolescents. Our healing professionals combine aspects of the latest in clinical care with a personalized approach to each youth's individual needs. We offer options for adolescents experiencing mental health or addiction issues:

Beach House provides screening, referral, and brief residential care for at-risk and runaway youth.

The **Residential Adolescent Program (RAP)** provides long-term (4-6 month) care for severely addicted youth.

The **Oaks** is a residential delinquent rehab program for boys, operated under contract with the Department of Juvenile Justice.

Outpatient addiction services for adolescents are located throughout Volusia County.

The **Keep Kids Drug Free Regional Prevention Center** is a resource and lending library. The center houses free substance and alcohol abuse and mental health materials. Serving parents, youth, community leaders, and professionals. The center is funded by the Keep Kids Drug Free License plate and can be purchased at your local tag office.
